Total Reclaim processes electronics, fluorescent light bulbs, batteries, and Styrofoam for recycling at their facility. AOR members got to see the beginning stages of electronics processing and dismantling and got to see the Styrofoam densifier in action.

Legislative Update By Megan Ponder, Legislative Chair

As we prepare for the upcoming 2015 legislative session, I'd like to take a minute to recognize the collective effort of AOR members in the development of the DEQ's materials management legislative proposals. Materials Management in Oregon: A 2050 Vision and Framework for Action was adopted in 2012 following a workgroup effort to identify goals and recommendations. After adoption, DEQ prioritized actions and established a workgroup to evaluate potential updates to Oregon's solid waste and recycling statutes. AOR has dedicated significant time during the last three conferences to discuss the process and the proposed legislative concepts, and many AOR

members have participated in workgroups, supporting subgroups, and the AOR legislative subcommittee. AOR members have provided valuable input at numerous meetings, conference calls, and AOR events. I, and other members of the board, have worked alongside AOR members and have heard AOR members' support, concerns, and suggestions. We are a diverse organization that shares a common vision to achieve a system of sustainable materials management. Through this multi-year process, AOR members have played a key role in the development of a legislative package that will be AOR's main priority in the 2015 session. The AOR Board supports the DEQ proposals, and I look forward to working with the legislative committee and the board on this package during session. The legislative committee will meet again prior to the session to discuss additional issues of interest for 2015, including clean fuels. I anticipate an active 2015 session for AOR and encourage interested members to join the legislative committee. The committee will meet regularly during the legislative session, and meetings are open to all members. I look forward to our work ahead.

Markets Update By Chris Thomas, Markets Chair

Commodity markets on the West Coast have been softening over the last quarter. Decreased domestic demand for old newsprint (ONP) continues to apply pressure to the export mixed waste paper (MWP) market. Old Corrugated Cardboard (OCC) has shown some signs of improvement recently, but is generally pretty soft as well.

Plastic grades have been pretty strong, but continued declines in oil costs will eventually take a toll on plastic pricing. In the last few months, steel pricing has show the sharpest declines and most believe it will continue into 2015.

Financial Report: Looking to Be Leaner and Greener in 2015

With a few months under my belt as AOR's treasurer, I am excited to be able to contribute to this wonderful organization and am looking forward to the work ahead. The last few years have been rough, financially speaking, with 2014 projected to be our third year in a row with expenses exceeding income. This trend has been due to several factors, including the overall economy's impact on haulers and local government agencies which have had to scale back how many people attend the conference, increasing organizational and conference fees, and declining membership numbers (in part due to industry consolidation).



Despite this trend, I am impressed with how the organization has responded. Our resource and communications directors found some creative ways to be more efficient resulting in significant savings. The board has a new conference chair, Fred Stemmler, who — with Patty Morgan and others on the conference committee — are bringing some great new ideas that we hope will help bring additional savings while generating some new sources of income. We now have two new seats on the board which are both aimed at increasing revenue. As marketing chair, Julie Jackson will be working with our newest board member, Joanna Dyer, who will also fill a new role on the board as our fundraising chair. Together this dynamic duo are bringing new energy and lots of innovative ideas on ways to raise funds to enable AOR to continue to be the successful organization that it has been for the last 3+ decades.

At our recent board retreat we had a very productive day and I left feeling energized and that we have a clear sense of direction to move AOR forward. I look forward to the year to come and the exciting new programs that AOR will make available to its members.

Meet Your New Fundraising Chair

I grew up in a suburb south of Boston, Massachusetts. Soon after receiving a B.S. in Biology from Villanova University in Pennsylvania, I migrated to Oregon for "the summer" many, many years ago.

I spent a couple of years working at Outdoor School as a field instructor before discovering the Master Recycler Program, which led me to my first AOR conference (on scholarship) in 2001. Later that year, I began working at SCRAP as an AmeriCorps member developing their education and outreach program focused on reuse and waste prevention. I continued to work at SCRAP through 2008 in a variety of roles: store coordinator, communications and marketing coordinator, and eventually co-director.



I left SCRAP to pursue an MBA in Sustainable Business at Bainbridge Graduate Institute where I focused many of my projects on waste related topics. After graduating, I began working for the City of Beaverton in 2009 as the Waste Reduction Coordinator. In this role, I coordinated the Recycle at Work (RAW) program for the City and sat on Metro's Business Recovery Work Group (BRWG). In addition, I assisted in administering the City's solid waste franchise, developed marketing materials, and most recently led the Green Move, an employee engagement effort that encouraged employees to reuse and recycle as much as possible while downsizing prior to moving to a new building. The Green Move diverted more than 60,000 pounds of materials to recycling and reuse and led to the implementation of internal waste prevention efforts such as durable dishware, centralized office supplies, and a reuse center for other office products. I recently left my position in Beaverton to pursue new pathways in the waste world. I am also on the steering committee for the Oregon Chapter of the Reuse Alliance.

I joined the AOR board to assist with fundraising efforts. In 2011 and 2012, I coordinated the silent auction at the annual AOR conference which raised more than \$1,000 each year for scholarships. With this new board position, AOR is looking to expand fundraising efforts so that we can continue to provide the educational and networking opportunities that you've come to expect from AOR. Although I am not a professional fundraiser, I love attending fundraisers. I love raffles. I love playing bingo. I love planning events. I love coming together for a common cause. I think there are a lot of possibilities for AOR that can simultaneously achieve the goals of bringing people together and bringing in funds. A fundraising committee will be forming soon. Though the board has been working on a piecemeal strategic plan over the past few years, we opted to hire a facilitator to help pull all the pieces together and move us closer to a final product (and to ensure that the board's previous efforts weren't lost). Organizational development consultant Jonathan Poisner served as facilitator extradordinaire, expertly guiding us through key, big picture questions such as "what value does AOR have

for its members?" and "how can AOR continue to be a vital resource for recycling in Oregon?"

We tackled both our programmatic offerings as well as the way the organization operates internally, and after several long hours of conversation a framework plan started to emerge. I worked with Amy Roth, AOR's Resource Director, to capture the board's thoughts from the retreat and translate them into a draft strategic plan, and I anticipate that we will have a snazzy, final version to share with the membership at the start of the new year! However, like most state recycling organizations across the country, the stark reality is that our organization is spending more money than it's taking in and that our usual revenue streams just aren't cutting it anymore. That said, I feel so lucky that AOR has such a robust board to creatively tackle this issue and our brainstorming at the retreat was inspiring. I also feel particularly confident knowing that we have two new positions which will directly work towards remedying our cash flow problem.

Speaking of board positions, I'd like to officially welcome our brand-new fundraising chair, Joanna Dyer! Joanna was appointed by the board to fill the fundraising chair position recently vacated by Eric Crum, who resigned from the board due to an overflowing plate of responsibilities. Thanks for stepping up to serve AOR, Joanna!

Remembering AOR Award Recipient Dean Williams By Ali Briggs-Ungerer, Chair

AOR awarded Dean Williams the Alice Soderwall Reuse and Waste Prevention Award at Sustainable Oregon 2014 for his extraordinary work salvaging and repairing bicycles destined for the scrap pile, and then putting functional bicycles into the hands of those who most needed them.

When retired veteran Dean Williams saw that repairable bicycles were being discarded and headed towards the scrap metal pile at a recycling center in McMinnville, he took action. Dean became committed to transforming these bicycles



for area children and adults, and in 2012 he established the Pedal Power Partnership in conjunction with Waste Management and the Yamhill Community Action Partnership. Over 2,000 bicycles were recovered through the Partnership in just two years and Dean was actively pushing to expand the Partnership's reach farther and farther. In his own words: "I guess you could say we deliver bikes and a whole lot of joy."

It's with a heavy heart that I share the news of Dean's passing. After fighting a sudden and severe battle with pancreatic cancer, Dean passed away the day after Thanksgiving. Conference Chair Fred Stemmler spoke to him shortly after his diagnosis and he was both defiantly strong and peaceful. Fred notes that Dean drew great strength from his faith and religious community and was fully committed to continue his charitable work despite his declining health, and that his generosity was a thing to marvel at and aspire towards.

He is survived by his wife Sharon and his son Erik. Funeral services were held December 13 at 10am at the City Outreach Ministries in McMinnville. A memorial fund is being established by Dean's many community partners at Bank of America in McMinnville. For more information, contact Waste Management (Karen at 971-261-4013).

Dean's passion, dedication, and hard work touched so many people in the past few years, and his efforts serve as a model for all of us committed to waste prevention. He will be remembered fondly.

ORPET Enters New Era with Partner Merlin Plastics USA Ltd.



Plastics recycler ORPET, located at the Port of St. Helens, began a new era with the addition of partner, Merlin Plastics USA Ltd. on November 7. Merlin Plastics purchased the ownership stake from Pacific PET, LLC. The Merlin Plastics group operates multiple plants on the West coast of North America. They have 26 years of experience processing PET and other containers, converting them to a variety of finished grades, including FDA approved pellets.

ORPET converts Oregon deposit beverage containers into clean, washed flake used in the manufacturing of new plastic products.

Oregon Beverage Recycling Cooperative (OBRC), the organization that executes the functions of Oregon's bottle bill on behalf of beverage distributors, has been a partner in ORPET since its inception in 2012, and provides ORPET with a clean and stable source of recyclable plastic.

"ORPET has always been a project Oregonians could feel good about. Now that we are partnered with a wellestablished container processor in Merlin Plastics, the opportunities for using recycled Oregon PET only increase," says John Andersen, President of OBRC. "This is a step forward in our mission to continuously improve recycling practices surrounding Oregon's iconic bottle bill."

Metro Crowns Winner in Let's Talk Trash Film Contest

On Nov 10, more than 200 people attended Metro's Let's Talk Trash Film Gala at the Portland Art Museum to see locally-made films about the Portland's region's waste. Of five finalists, "There Is No Away" was chosen by the audience as the winner, and \$500 was awarded to the film maker, Susan Beraza. You can watch the final films here.

The film contest was part of a series of Let's Talk Trash events Metro held this year to raise awareness about how the Portland region
